PROVISIONAL ORDER

1. Hiraba Balghar school, c/o.Jay Somnath High.Sec School, B/H methodist church, khokhara, Ahmedabad-380008, has filed its proposal for Academic Year 2022-23 for Pre-Primary Section (GSEB Gujarati Medium) along with relevant documents. After considering the said proposal along with the documents attached therewith, the Fee Regulatory Committee hereby determines the provisional fees for the academic year 2022-23.
2. After considering the proposal of school of dated 11.05.2022 to fixing the fees for the year: 2022-23 and other documents and perusal of the Affidavit order of FRC dated: 15.11.2021 for the academic year: 2021-22 that is for Jr.kg & Sr.kg Rs. 14800/- (GSEB Gujarati Medium) for the academic year: 2021-22.
2. The school has submitted its income and expenditure statement for the year 2022-23, Looking to the statement and verify the above statement it is

found that some of the expense found disallowable and not for education purpose from the total expense of Rs. 43,48,729.50/-, and by considering the strength of student's it is found that the proposed fee structure is not found satisfactory. But looking to the teacher's salary some reasonable fee structure determines by the FRC.

3. Hence following passed following provisional order for A.Y: 2022-23.

You are further directed that any excess fees charged from the students over and above the above mentioned ceiling shall have to be refunded to the students.

Terms and conditions:

1. It is directed that the School is not permitted to collect fees for any quarter of 2022-23, more than the provisional fees determined for the year 2022-23.
2. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees except one month fees by way of admission fees only in case of new admission and thereby causing no extra burden on the students.
3. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
4. If the School is aggrieved by the provisional fees determined by the Committee, the school has a right to file objections before the committee within 7 days from the date of receipt of this provisional order.
5. The school is directed to place the order determining the provisional fees on its notice board as well as on the website of the school.
6. If School have no any objections on above provisional order of the A.Y : 2022-23, then treated above order as final order and as per the final order, school is permitted to collect the fees for the academic year 2023-24 and 2024-25 by giving

5% rise on the above provisional fees order. i.e. (add 5% in the A.Y : 2023-24 and on above add 5% in the A.Y : 2024-25.)
