(2) The notice to remain present on 05-10-2024 issued. The school representatives Mrs. Monalisa Christian (Principal), Shree Harsh M. Patel (Admin) and Shree Arun A. Sharma (Accountant) was present in the hearing. It is requested by him that the school has proposed the fees in the affidavit. The school has produced relevant information's for determination of fees with audit report of concerned year. They requested to grant the fees as proposed for smooth running of the school. During the hearing the FRC has taken into consideration all points, with documents submitted, necessary for determination of the fees.

(3) The FRC is required to exercise the power conferred upon it in a balanced manner so as to see that on one hand the school management is not deprived of the legitimate fees to be charged from the students and the students also should not suffer by paying exorbitant fees charged by the Self Financed School. The objective of the Gujarat Self Financed Schools (Regulation of Fees) Act, 2017 is to prevent "profiteering" as defined in Section-2(r). During the hearing the school has submitted written consent and agreed to determined the fees of academic year 2024-25 and the FRC has determined the fees accordingly. Hence considering the consent letter, the FRC has determined the just and fair fees considering the audited report of the school for the academic year 2024-25 as against the fees proposed by the school for Secondary Section (Std. 9<sup>th</sup> & 10<sup>th</sup>) (GSEB English Medium) as shown in below table.

**:: Terms and conditions ::**

1) The School shall not collect fees amounting to more than one quarter at a time.




2) The school is not permitted to collect fees more than the final fees determined for the academic year: 2024-25 except permissible.

3) It is also made clear that the School should either return the excess fees collected by the School for the year 2024-25 or give adjustment thereof, in the fees of 2025-26.

4) Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.

5) If the School Management has any grievance against the final fees determined by the Committee, it shall have a right to file revision application under Section-12(3) of the Gujarat Self Financed Schools (Regulation of Fees) Act, 2017 before the Fee Revision Committee in Form-V within a period of 21 days from the date of receipt of the order with challan of Rs.10,000/- as process fee.

6) The School is directed to place the final order determining the final fees on its notice board as well as its website respectively in Gujarati and English.
